HIGH SCHOOL GRADUATION REQUIREMENTS

Because graduation from high school provides students with opportunities for postsecondary education and/or employment, the Board of Education desires to prepare each student to obtain a diploma of high school graduation.

For graduation, a district high school student must earn 220 units during grades 9-12.

- 1. English 40 units
- 2. Social Studies 30 units, including:
 - a. 10 units of World History and Geography in grade 10.
 - b. 10 units of U.S History in grade 11.
 - c. 5 units of Government in grade 12.
 - d. 5 units of Economics in grade 12.
- 3. Mathematics 20 units, including 10 units of Integrated Math I if two semesters of Integrated Math I were not successfully completed at the middle school.
- 4. Science 20 units, including:
 - a. 10 units in Physical Science; or the year course of Environmental Science I-P, Electronics 1 and 2 (year course), or Agriculture, Physical Science-P; or one year of chemistry or one year of physics.
 - b. 10 units in Biology/Life Science; or the year course of Environmental Science II or Human Anatomy and Physiology-P; or one agriculture A course and one agriculture B course.
- Fine Arts or Foreign Language or Career Technical Education (CTE) 10 units
 Fine Arts courses include all music, art, drama and photography classes and architectural Design.
- 6. Health 5 unit (grade 9)
- 7. Physical Education 20 units, including:
 - a. 10 units in grade 9
 - b. 10 units in grade 10-12

HIGH SCHOOL GRADUATION REQUIREMENTS (continued)

Final marks through the eighth semester in grades 9-12 are used to compute overall grade point averages for the valedictorian and salutatorian. Final marks through the seventh semester are used to determine the gold tassel award.

Certificate of Credit Completion

Students who have met all graduation requirements will be eligible for a Certificate of Credit Completion.

Certificate of Completion

Instead of a high school diploma, a student with disabilities may be awarded a Certificate of Completion.
